SECTION – 1

The Football Club Inc (“the Club”) applies for affiliation with the SANFL Juniors and to field teams in the junior football competition conducted by the SANFL Juniors.

SECTION – 2

CLUB AGREEMENT

In consideration of the SANFL Juniors accepting the Club’s application to affiliate with the SANFL Juniors, the Club does hereby agree to:

- Abide by the Charter, Rules and Regulations of the SANFL Juniors and of the Constitution, Rules and Regulations of the SANFL and the AFL
- Abide by the SANFL Juniors and SANFL’s Policies, practices, procedures, determinations and resolutions and will not act in any manner inconsistent with any practice, policy, procedure, determination, resolution or contractual rights or obligations entered into by SANFL Juniors or the SANFL and to act at all times in the best interests of developing the game of Australian Rules Football
- Ensure that all players and/or participants compete in accordance with the laws of Australian Football.
- Ensure that all players and participants complete a Registration Form and maintain such registration during the term of the Affiliation.
- Pay all club fees when due and payable to the SANFL Juniors.
- Supply a full range of all necessary support staff for all teams nominated.
- Maintain its affiliation with the SANFL Juniors which affiliation shall continue until terminated in accordance with the SANFL Juniors Rules.
- Abide by and make all members, parents, supporters and associates of members aware of the SANFL Juniors Code of Conduct and the implications for non-compliance.
- Give permission for photographs and videos to be used by the SANFL Juniors in any form the SANFL Juniors sees fit. Photographs and videos will be displayed on the SANFL Juniors and SANFL websites, used in newsletters/publications and any other media format and with such photographs and videos to be filed at the SANFL Juniors Offices.
- Use its best endeavours to ensure that each of its officials concerned or taking part in the management of the Club will maintain a high and good reputation and will not act or behave in a manner which would adversely affect the image or reputation of the SANFL Juniors.
- The SANFL Juniors, in accordance with its Rules imposing penalties upon the Club due to any team, player, spectator or official bringing the SANFL Juniors into disrepute as set out in the Rules of the SANFL Juniors from time to time.
- Nominate and notify the SANFL Juniors of the Delegate or Proxy Delegate to represent the Club at each Football Development Council meeting.
- Ensure that its Delegate or Proxy Delegate attends all Football Development Council meetings when convened.
- The SANFL Juniors or its nominee for the purpose of considering any application for affiliation with the SANFL Juniors examining and inspecting the Club’s records, oval(s), change rooms, clubrooms and facilities to ensure that they are of a standard suitable for the playing of junior football.
- Not directly or indirectly do any act or thing whereby any of the SANFL or SANFL Juniors Intellectual Property rights used in the conduct of the SANFL Juniors Competition is prejudicially affected.
- Not enter into agreements with sponsors and/or organisations, which conflict with sponsorship arrangements with SANFL Juniors protected sponsors.
