The SANFL Community Football Education Grant provides financial support towards accredited education courses for volunteers

#### **Grant Objective:**

Improve the skills and capabilities of coaches, umpires and administrators through education and training programs.

#### **Eligible Courses**

Accredited education courses delivered by recognised training providers including but not limited to:

- First Aid
- Coaching
- Sports Trainer
- Liquor Licensing

#### **Grant Round:**

1<sup>st</sup> November 2017 - 1<sup>st</sup> of October 2018

#### **Grant Funding:**

- Reimbursement up to 75% of the total cost (subject to CFL assessment)

1. Applications will be subject to approval by the SANFL Community Football.
